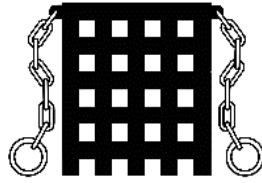

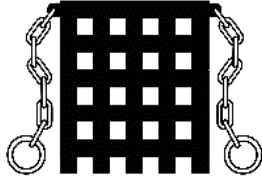
5.00 pm Public Question Time Session
