#### **LANGPORT TOWN COUNCIL – Council Minutes**

# Minutes of the Meeting of Langport Town Council held on Tuesday 20<sup>th</sup> May 2025 at 7.00pm in the first-floor meeting room, Langport Town Hall

In attendance was Gerard Tucker, Town Clerk, Morag Kelly, Deputy Clerk, Somerset Cllr Richard Wilkins and 7 members of the public. There were no members of the press present.

Public Participation – Items raised included:

Removal of the lighthouse on Cocklemoor

A request that draft minutes are placed on the website prior to the next meeting

Clarification on the car park lease agreement

A presentation of an independent car park occupation survey

Cllr Wilkins reported on the closure of the maternity ward in Yeovil. He was asked to identify why Langport's pavements have not been left in the same condition as Curry Rivel following works. He was also asked to research why signage at a road closure is not better displayed.

### TC2025/1 Election of Chairman of the Council and Acceptance of Office. (LGA 1972 s14 (1), 15(1&2), 33(1) and 34(1&2))

Cllr Dromgoole was proposed for the position of Chairman of the council by Cllr Donald, seconded by Cllr Glas and unanimously **AGREED.** 8-0-0. The declaration and acceptance of office will be signed on Tuesday 26<sup>th</sup> May on Councillor Dromgoole's return.

## TC2025/2 To receive Apologies for Absence and to approve the reasons given (LGA 1972 s85 (1))

Apologies were received and accepted from Cllr Paterson (holiday) and Cllr Dromgoole (holiday)

#### **TC2025/3 Declarations of interests**

Members to declare any interests, including Disclosable Pecuniary Interests they may have in agenda items that accord with the requirements of the Town Council's Code of Conduct and to consider any prior requests from members for Dispensations that accord with Localism Act 2011 s33(b-e) (NB this does not preclude any later declarations)

Cllr Peterkin declared an interest in agenda item TC2025/14 as she had supported Kate Lynch with the painting that requires framing

#### TC2025/4 Appointment of Vice Chairman of the Council.

Cllr Peterkin was proposed for the position of Vice Chairman by Cllr Glas, seconded by Cllr Donald and unanimously **AGREED**. A statement from the Chairman of the council Cllr Dromgoole was read to the meeting thanking Cllr Glas for his support as Vice Chairman for the previous three years.

# TC2025/5 To approve and sign as a correct record the minutes of the Town Council Meeting held on Tuesday 15th April 2025 (LGA 1972 sch 12, para 41 (1))

The minutes from the previous meeting were agreed and duly signed by the chair as being a true and correct record of that meeting.

#### TC2025/6 Town Clerk's Oral Report -

including use of delegated powers and update on progress since the last meeting:

- The clerk informed that a drop in meeting to address concerns about the pending railway bridge works and the closure of the A378 has been organised for Wednesday 11<sup>th</sup> June at the Langport and Huish Episcopi Sports and Social Club, Eastover, Langport. The session will be attended by representatives from Morgan Sindall, Network Rail and Somerset Council and will be between 4.30pm and 7.30pm.
- Litter picking responsibility for insurance and monitoring purposes is to be transferred from the Inland Waterways Association to the Town Council with immediate effect.
- Additional wheeled bins during fair week have been ordered for the town at a cost of £80.
- Following a recent incident in the car park, it became evident for the need to extend the CCTV coverage of Cocklemoor car park. It is intended to obtain quotes to improve this service.

# TC2025/7 To receive written or oral reports from meetings and training attended by councillors on behalf of the Council

#### TC2025/8 Financial Regulations

The review of the town council's Financial Regulations is identified in the Standing Orders of the council to take place immediately after the formation of a new council – normally every four years. The Financial Regulations state in 8.5 *The Council shall consider the need for an investment strategy which is to be reviewed annually.* As an investment strategy is being considered, the opportunity is provided to review the Financial Regulations. There were no questions, comments nor amendments raised in relation to the Financial Regulations.

The town pump has been included, yet is considered to be an asset of Landmark Langport. The clerk is to seek clarification.

Councillors requested that a further column is added which identifies the insurance value of each item

#### TC2025/14 To consider a grant application (for less than £1,000)

An application has been submitted to the Town Council by Kate Lynch who has requested a contribution of £250 towards the cost of framing the 'Between the River and the Railway' artistic map of Langport. Cllr Peterkin having declared an interest in this item did not partake in any discussion nor decisions taken. Cllr M Crumb led this item. Cllr Glas proposed, seconded by Cllr Donald and unanimously **AGREED** 7-0-0

Having approved this application, £8,150 remains in the grants budget.

# TC2025/15 Application to install a Paddleboard and Kayak rental solution on Cocklemoor

A request has been received from James Tuck to install a SUP and Kayak vending machine near the river on Cocklemoor. For a fee, users will be able to access Stand Up Paddleboards and kayaks. Mr Tuck presented his idea which in principal was supported by Councillors. Cllrs Wilson and R Crumb are to join with the Town Clerk when discussing the detail of location, safety, promotion, security, power supply etc.

#### TC2025/16 Society of Local Council Clerks (SLCC) membership

continued SLCC membership at a cost of £80 for the Town Clerk to remain a member of this organisation.
