JC2025/11 To receive Apologies for Absence and to approve the reasons given (LGA 1972 s85 (1))

JC2025/12 Declarations of interests

JC2025/13 To approve and sign as a correct record the minutes of the Joint Council Committee Meeting held on Wednesday 4th June 2025 (LGA 1972 sch 12, para 41 (1)

The minutes of the previous meeting were considered a true and accurate record of that meeting and were duly signed by the Chair.

JC2025/14 To consider a report on long-stay car park provision

Summarised the below options for use of a long stay carpark in the area.

1. Extension to St Mary's carpark

- 2. Lease of parcel of land opposite Westover Garage
- 3. Land on Northmoor (behind former Travis Perkins)
- 4. Land adjacent to cricket field
- 5. Land on Northmoor (behind Tesco)

AGREED It was resolved to appoint an independent Highways Consultant to undertake a feasibility study of all proposed sites. The Clerk to HEPC will initiate the procurement process and manage the engagement.

JC2025/15 To consider a meeting to discuss the Sedgemoor Land Recovery Project Councillors reported the outcome of a site meeting with Sedgemoor Land Recovery Team. Each council will be asked to if they wish to continue supporting, with more detail to be obtained. At this stage no financial commitments have been made.
